## Notice of Availability

**2017 Shasta Federal Transportation Improvement Program Formal Amendment No. 7**

The Shasta Regional Transportation Agency (SRTA) is the Metropolitan Planning Organization (MPO) for Shasta County and its incorporated cities. As the MPO, SRTA is required to prepare a Federal Transportation Improvement Program (FTIP). The FTIP is a four-year program of projects for the maintenance, operation and improvement of the transportation system. The 2017 FTIP was federally-approved December 16, 2016, and is being amended. Proposed 2017 FTIP Formal Amendment No. 7 is available for review at www.srta.ca.gov, and at the below address.

Revisions include: cost increases (\$28.776M) for two 2017/18 roadway preservation projects, as well as the addition of a new \$26.422M roadway preservation project in 2018/19 on Interstate 5 in and near Anderson; significant adjustments to the Highway Bridge Program (HBP), primarily delaying local bridge replacements programming to outlying years due to statewide HBP project cost increases; and adding Active Transportation Program grant funding (\$2.538 million) for an award received by the city of Redding for its West Street Area School Safety Improvements Project—total project cost \$3.196 million over years 2017/18 and 2019/20. More detail is included in the amendment.
