## ORDINANCE NUMBER BFPD 2018-01

At a regular meeting held on Tuesday, May 8, 2018, the Board of Directors of the Burney Fire Protection District passed Ordinance No. BFPD 2018-01, establishing a new schedule of fees for ambulance services.

Pursuant to Health and Safety Code Section 13916, the specific fees to be charged for service must be adopted by the Board by ordinance after providing notice and holding a public hearing, and per Government Code Section 6066 a notice of public hearing was provided, with the opportunity for oral and written presentations to be made and received were held, thereby all requirements of California Government Code Section 66018 are hereby found to have been complied with.

The Schedule of Ambulance Fees set forth herein as Exhibit "A" is hereby adopted and shall be applied by the District and/or its designated contractor. This Ordinance shall take effect no sooner than thirty days after the date of its adoption.
