NOTICE IS HEREBY GIVEN that the Burney Water District (BWD) has prepared an Initial Study pursuant to the California Environmental Quality Act (CEQA) for the project described herein. Based on a preliminary analysis, the BWD Board of Directors (Board), as lead agency, intends to adopt a Mitigated Negative Declaration (MND) for the project. A MND is a statement that the project will not result in a significant adverse effect on the environment.
