Effective with the log of October 12, 2018 The Shasta County Sheriff's Department has effectively eliminated all useful or informative public information from it's daily log which might aid the citizens and/or businesses in taking steps to properly protect themselves, or be forewarned of who or what type of problems are occurring in their neighborhoods.

This is the latest from the Sheriff's Department. The Shasta County Sheriff's Office is in the process of implementing an integrated records system together with the City of Anderson Police Department, the City of Redding Police Department, the Shasta County Probation Department, the Shasta County District Attorney and the Superior Court of Shasta County.

As such, we have made changes to the Sheriff's Office webpage and information which is posted including discontinuing the posting of daily logs. Be assured, the Sheriff's Office will continue to provide ALL legally required information.

Effective 8:00 a.m. November 15, 2018 the Sheriff's Office Call Log Link will be removed.

What they don't say is that without the log you don't know what to request.

It is bad enough that the Sheriff won't fight crime, it is even worse when he violates the law.
